## **Continuing Medical Education**

According to the American Medical Association (AMA), "continuing medical education (CME) consists of educational activities which serve to maintain, develop, or increase the knowledge, skills, and professional performance and relationships that a physician uses to provide services for patients, the public or the profession."

AMA PRA Category 1 Credit<sup>™</sup> is the most commonly accepted form of CME credit for physicians. AMA PRA Credit is recognized and accepted by hospital credentialing bodies, state medical licensure boards, medical specialty certifying boards, medical specialty societies, Joint Commission and other organizations. AMA PRA Credit is also the basis for receiving the AMA Physician's Recognition Award.

AMA PRA Category 1 Credit<sup>™</sup> must be planned by an accredited provider, such as Nationwide Children's Hospital, and meet certain qualifications, such as presenting content appropriate for a physician audience, addresses demonstrated educational needs, communicate clearly identified objectives, etc. AMA PRA Category 2 Credit<sup>™</sup> is defined as all educational activities not designated for Category 1 that: 1) comply with the AMA definition of CME; 2) comply with the AMA ethical opinions on Gifts to Physicians from Industry and on Ethical Issues in CME; and 3) a physician finds to be a worthwhile learning experience related to his/her practice. Accredited providers do not designate activities for AMA PRA Category 2 Credit<sup>™</sup>. AMA PRA Category 2 Credit<sup>™</sup> may be claimed for activities such as teaching residents, reading authoritative medical literature, and consultation with peers and medical experts.

For medical license renewal in Ohio, the State Medical Board requires a total of 100 CME credits in a 2 year period. At least 40 credits of CME must be earned in Category 1, although the total 100 credits may be Category 1. However, 60 credits of the required 100 can be claimed as Category 2.
