Toledo Health Systems Partner to Improve Housing in Lucas County

Nationwide Children's - Toledo, Mercy Health and ProMedica are partnering to address the social, economic and environmental factors that impact the health of children and families in the Toledo community. Each system has invested in social determinants of health individually but during recent months agreed to work together to have a stronger impact on addressing these critical issues that affect childhood and overall community health. Collaborating with community organizations, these local hospital systems will improve housing affordability and quality, support lead remediation and reduce lead exposure for families in northwest Ohio.

As part of this collaboration, Nationwide Children's - Toledo will work with Maumee Valley Habitat for Humanity (MVHFH) to rehabilitate 53 owner-occupied residential housing units in Lucas County as part of MVHFH's Home Preservation programs. Flovent Discontinuation Announcement

The producers of brand name Flovent® HFA (fluticasone propionate) and Flovent® Diskus® (fluticasone propionate inhalation powder) have announced that effective January 1, 2024, these products will be discontinued. This is a commonly prescribed inhaled corticosteroid medication, often used in the treatment of asthma. The authorized generics, fluticasone propionate HFA (generic for Flovent® HFA) and fluticasone propionate diskus (generic for Flovent® Diskus®) are now available.

According to the FDA, an authorized generic is an approved brand name drug that is marketed without the brand name on its label. Other than the fact that it does not have the brand name on its label, it is the exact same drug product as the branded product. Pharmacies can substitute the generic

without an updated or new prescription if refills remain on the original Flovent® prescription. Prior to refill, patients should check with their insurance to determine if they cover the generic medication, or if they prefer a different inhaled medication.

Newborn Screening for Cystic Fibrosis

Did you know that missed and delayed cystic fibrosis (CF) diagnosis still happens in Ohio?

Diagnosis and treatment of CF have dramatically improved over the past 20 years with the introduction of newborn screening (NBS) and CFTR modulator therapy. Despite this, there are still infants with an abnormal screening for CF who do not get the recommended sweat chloride testing within 30 days of life. This can lead to missed or delayed diagnosis.

New CF medicines can be started as young as 30 days.

Depending on the gene mutations, some CFTR modulators can be started very early. These modulators are life-changing for patients and dramatically improve outcomes, especially the earlier they are started. Early diagnosis matters.

Help to identify all infants with CF.

The Abnormal CF Newborn Screen Response Team is here to help provide clear communication of NBS results to families and to help schedule sweat chloride testing. CF NBS results can be confusing for both patients and primary care teams. Many barriers exist contributing to delays in diagnostic testing. We can help interpret screening results and coordinate follow-up testing as indicated.

NBS for CF will miss 5-10% of infants with CF.

Please remember that newborn screening does not rule out a diagnosis of CF. Newborn screening is a great tool, but as with any screening test, it is not perfect. If there are any concerns a patient has CF, a sweat test and evaluation by an accredited CF center should be arranged *even if the patient had a normal newborn screening for CF.*

Mercado, DMD, PhD, is a craniofacial orthodontist in the Nationwide Children's Cleft Palate-Craniofacial Clinic and a clinical associate professor of Orthodontics at The Ohio State University College of Dentistry. She received her dental degree from the University of Puerto Rico. Her general practice residency and oral biology master's degree are from The Ohio State

University. She completed the dentist-scientist program from the National Institutes of Health, which awarded her a specialty degree in orthodontics and a PhD at The Ohio State University. HOMECARE UPDATE

Homecare 2024 Updates for Providers

Homecare has several services that have increased the number of counties they cover. Per announcements in 2023, Homecare Medical Equipment delivers home medical equipment and supplies to all of Ohio's 88 counties. The only exclusion is bili-blankets, which are currently only available in Homecare's primary nine-county service area due to regulations. HME will be trialing new ways of providing bili-blankets to all 88 counties and will continue to update providers on accessibility.

In 2023, Therapy Services expanded from providing services in only Franklin County to include Delaware County. This year, Homecare's Therapy Services are also available in Fairfield County.

Intermittent Skilled Nursing has begun accepting referrals for patients living in Knox and Muskingum counties in addition to their original nine-county service area.

We have received requests from community providers for an easily accessible general Nationwide Children's Homecare referral form, which is now online. The "Professionals" page also includes payor listings, a service area map and specifics on referrals to Asthma Express. For details, go to
