Richard Wood, MBChB, FCPS(SA), has been appointed chief for the Department of Pediatric Colorectal & Pelvic Reconstructive Surgery at Nationwide Children's and assistant professor of Pediatric Surgery at The Ohio State University. Dr. Wood's areas of clinical interest are complex pelvic reconstructive surgery including anorectal malformations, cloacal malformations, Hirschsprung disease and the surgical management of severe constipation. His surgical expertise is expansive – having provided care to hundreds of patients at Nationwide Children's as well as his deep experience in re-operative colorectal surgery and surgical reconstructions resulting from the rarest of conditions, such as complex cloaca and complex vaginal reconstruction.

Dr. Wood completed fellowship training at the Red Cross War Memorial Children's Hospital in Cape Town, South Africa. The hospital serves as the national resource for children with colorectal reconstructive needs. Dr. Wood has been prolific in his academic productivity, publishing many peer reviewed journal articles as well as book chapters on cloacal malformations, anorectal malformations and Hirschsprung disease.



Musculoskeletal Radiology Now Performing Non-sedated Musculoskeletal Procedures

Nationwide Children's Radiology Department has developed a comprehensive Musculoskeletal Program which will now encompass both imaging and inventions for musculoskeletal treatments. Traditionally, all image guided musculoskeletal procedures have been performed by Interventional Radiology, including musculoskeletal joint, tendon sheath, ganglion cyst, and bursal procedures. Non-sedated musculoskeletal procedures are now performed by Musculoskeletal Radiology. These orders are now live in EPIC. *For more information, see the insert in your packet*.

New Process for TB Screening

Effective November 2019, per recommendations by the Centers of Disease Control and Prevention (CDC), Nationwide Children's Urgent Care Centers will cease TB screenings using PPD (purified protein derivative) skin tests. Our Urgent Care Centers now only offer the Quantiferon Gold (QTFGP) blood test to screen for TB in children ages 2 and older. For Quantiferon collection questions, contact Laboratory Client Services at (614) 722-5477. For more information, see the insert in your packet.

Call PDC for Urgent Endo Appointments

If primary care providers have urgent or emergent clinical concerns about a patient and are looking to make a referral to Endocrinology, call Physician Direct Connect (PDC) at (614) 355-0221.

Urgent or emergent clinical concerns include:

- Newly diagnosed congenital hypothyroidism with TSH > 50
- Abnormal 17-hydroxyprogesterone on newborn screen
- New onset type 1 diabetes
- New onset type 2 diabetes with HgbA1C $\ge 8\%$
- New onset hyperthyroidism (elevated FT4 and very low or suppressed TSH)

The above concerns should be discussed with a Nationwide Children's endocrinologist directly to help streamline the referral. Please DO NOT send requests for these urgent referrals via fax, online, or through your EMR, as this may delay necessary and proper evaluation and care.

Ohio Amblyope Registry Provides Free Treatment Supplies

The Ohio Amblyope Registry (OAR) is the first and only statewide registry for children with amblyopia. The OAR provides free treatment supplies (eye patches), educational information and support to any child (under the age of 18) and their family, in the state of Ohio, diagnosed with amblyopia. Once a child is diagnosed with amblyopia, a registration form is completed online at **OhioAmblyopeRegistry.com**. Upon registration, the child receives free eye patches, educational information and additional support. When the child needs additional patches, the parent/guardian can visit the OAR website to request additional patches. Every child, regardless of household income, can receive free patches during their patching treatment.

The Ohio Amblyope Registry is a grant-funded program through donations received from the check-off box on the vehicle registration form. The program is part of the Save Our Sight fund with the Ohio Department of Health. Reflections on Being a Part-Time Primary Care Pediatrician

As we became pediatricians, most (if not all of us) looked forward to a very productive, enjoyable and even fun-filled professional life. In my case, I believe all of these characteristics came true. A past mentor once told me that the first 10 years of your practice will be exciting — it will be very beneficial as you will reaping the benefits, happiness, and rewards of all your years of training. The second 10 years will be fulfilling, and you will become settled into a lifestyle. The latter years may sometimes seem like a difficult challenge, but hopefully still fulfilling. Medication Assisted Treatment for Addiction (MATA)

Virtually all addictions start during adolescence. Almost 4 million 12 to 25 year-olds in the U.S. have a substance abuse problem, but only 9% get any sort of treatment. The rate of suspected teen suicides using opioids has risen more than 50% since 2000. Between 1999 and 2016, almost 57,000 adolescents and young adults have died from a drug overdose.

Some indicators of possible substance abuse include changes in:

- Behavior
- Grades
- How they dress
- Who their friends are
- Moods
- Irritability
- Sleep patterns
- Every day activities
- Physical signs of dependence such as intoxication or hangovers

Nationwide Children's Medication Assisted Treatment for Addiction (MATA) is an outpatient program for adolescents and young adults, ages 14 to 21, for the treatment of prescription opioids (such as Percocet or oxycodone) or heroin addiction. Treatment involves using a drug called buprenorphine to stop withdrawal symptoms and to decrease drug cravings. For more information about MATA, visit **NationwideChildrens.org/MATA.**

There simply is not room in this announcement to fully capture the impact Dr. Brilli has had on Nationwide Children's since he arrived in 2008. For this, and so much more, Dr. Brilli holds a deep and lasting place in our hearts and the history of Nationwide Children's Hospital.

Always the collaborator, Dr. Brilli has worked tirelessly to spread Nationwide Children's learnings around the world. He is an inaugural member of the clinical steering team for the Solutions for Patient Safety (SPS) National Harm Reduction Collaborative, which now includes 135 hospital systems, and most recently he Co-Chairs the 50-hospital Children's Hospital Association Improving Pediatric Sepsis Outcomes Collaborative to bring more children the benefit of highquality care. His desire to spread knowledge is also evident in the number of professionals he has mentored during his career and the creation of the world's first peer-reviewed journal focused only on pediatric quality of care. Dr. Brilli is Co-Editor in Chief of this journal.

Dr. Brilli has also been a role model for our One Team values, and has relentlessly credited his colleagues and peers with many of these accomplishments. He has always acted in a manner consistent with his belief in the importance of elevating institutional capacity both at Nationwide Children's and other children's hospitals nationally -- insisting that a rising tide of collaborative efforts is essential for the safety and quality movement. A movement which has ultimately made health care safer for children everywhere.

I will miss working with Dr. Brilli, and I know many others will as well, but I am grateful he will still be with us part-time. And, of course, I am glad that he will be able to spend more time with his wife Cindy, their children and grandchildren. I am equally grateful to them for sharing Dr. Brilli with us for so many years and we wish them all well in this next exciting chapter of their lives.
