- ODM now allows APNs and PAs to sign orders and certify the need for home health services through a face-to-face encounter.
 - Signed orders still need to be faxed to (614) 355-1182. Referral receipt confirmation will be faxed back to the community practice.
 - Once the patient is authorized, a notice will be faxed to the community practice.
 - The community practice will be notified with any authorization problems.
 - Ongoing follow up during the season back to the community practice is by request.
 - The community practice will be notified by the home visit nurse if a patient is not compliant with a dose.
